

# ***Powered by Pink Power Up Your Team-Building Consistency Challenge***

## **Frequently Asked Questions**

**April 1 – June 30, 2022**

**1. What is *Powered by Pink Power Up Your Team-Building Consistency Challenge*?**

The *Powered by Pink Power Up Your Team-Building Consistency Challenge* is for Independent Beauty Consultants and Independent Sales Directors who achieve each *Powered by Pink* monthly challenge and add three *Great Start*-qualified\* personal team members during the challenge time frame! This challenge is designed to focus on selling and team-building in the months of April through June 2022.

**2. What are the qualifications for the *Powered by Pink Power Up Your Team-Building Consistency Challenge*?**

There are two qualifications to achieve this challenge. Independent Beauty Consultants and Independent Sales Directors need to:

- Earn the *Powered by Pink* Yearlong Program by selling enough product to place a \$600 wholesale order every month during the challenge time frame.
- Add three *Great Start*-qualified\* new **personal** team members during the challenge time frame.

**3. What are the qualifications for the *Powered by Pink Yearlong Program*?**

Independent sales force members who have a personal retail sales volume of \$600 or more in wholesale Section products in a given month during the challenge time frame can earn that month's *Powered by Pink* jewelry piece from the *Powered by Pink* jewelry collection by R.J. Graziano. The order(s) to support personal retail sales of \$600 or more in wholesale Section 1 product requirements per month can be placed in one single order or placed in cumulative orders, as long as the orders are placed in the same calendar month. In addition, Customer Delivery Service, Guest Checkout, and EZ Ship orders count toward your qualifying total amount.

**4. What is the challenge time frame for the *Powered by Pink Power Up Your Team-Building Consistency Challenge*?**

The *Powered by Pink Power Up Your Team-Building Consistency Challenge* time frame is April through June 2022. The two qualifications must be met by June 30, 2022, to be eligible to earn a specially designed three strand gold tone and pink pearl necklace by R.J. Graziano!

**5. What is the prize for the *Powered by Pink Power Up Your Team-Building Consistency Challenge*?**

Challenge achievers are eligible to earn a three-strand gold tone and pink pearl necklace designed by RJ Graziano!

6. **As an Independent Beauty Consultant or Independent Sales Director, how will I receive my prize from the *Powered by Pink Power Up Your Team-Building Consistency Challenge*?**

When you achieve the *Powered by Pink Power Up Your Team-Building Consistency Challenge*, your jewelry piece will be included in the next product order (does **not** need to be a qualified order) following the end of the challenge and month end. Consistency prizes will no longer be given out at special events.

7. **I have achieved the *Powered by Pink Power Up Your Team-Building Consistency Challenge*. Is there a time limit on when I need to place a product order to receive my prize?**

Yes. In order to receive your jewelry piece, you will need to place a product order of any amount within the three months after qualifying for the challenge. For this consistency challenge, you have until September 30, 2022. There is no minimum order requirement to receive your jewelry piece.

8. **Why can't my prize be included in the order which I earned through the consistency challenge? Why do I need to order after the challenge time frame to receive the jewelry piece?**

Because of the nature of the qualifications – calculating both the monthly challenges and the *Great Start*-qualified\* new personal team members for this *Powered by Pink Power Up Your Team-Building Consistency Challenge* – we need to wait until the end of the challenge time frame to process achievers. Therefore, to receive your jewelry piece in a product order, an additional product order must be placed after the challenge time frame.

9. **What if I started my business as an Independent Beauty Consultant in May or June 2022? Can I participate in the *Powered by Pink Power Up Your Team-Building Consistency Challenge*?**

No. The *Powered by Pink* Yearlong Program's consistency challenges require a minimum of three months' completion to earn. Due to the timing of this *Powered by Pink Power Up Your Team-Building Consistency Challenge*, there are not new Independent Beauty Consultant exceptions.

10. **What if I debuted as an Independent Sales Director in May or June 2022? Can I participate in the *Powered by Pink Power Up Your Team-Building Consistency Challenge*?**

Yes! You can participate in the challenge. The *Great Start*-qualified\* new personal team members from April, May and June 2022, will count for this challenge before you became an Independent Sales Director.

11. **Do the *Great Start*-qualified\* new personal team members need to submit their agreements during the challenge time frame?**

No. The *Great Start*-qualified\* new personal team members do not need to submit their agreements in the challenge time frame to count for the purposes of this challenge. They can be in their *Great Start* time frame, so they could have started their businesses in January, February or March 2022. As long as they become *Great Start*-qualified\* in April – June 2022, they count for the purposes of this challenge. Please see chart for agreement *Great Start* time frames below.

**12. What if I have a new personal team member who started her or his business in January 2022, but is not yet *Great Start*-qualified?\* If she or he becomes *Great Start*-qualified\* in April 2022, does she or he count?**

Yes! If the new personal team member started her or his business before April 2022, but becomes *Great Start*-qualified\* in April 2022, she or he counts toward the qualifications for this challenge. Please see chart for agreement *Great Start* time frames.

**13. What if I have a new personal team member who started her or his business in June 2022 and becomes *Great Start*-qualified\* in July 2022. Does she or he count?**

No. For the purposes of this challenge, *Great Start*-qualified\* new personal team members or new unit members must become *Great Start*-qualified\* by the end of the challenge time frame (June 2022) to count for this challenge. Please see chart for agreement *Great Start* time frames.

**14. Do I need to register or attend Seminar in order to receive my *Powered by Pink Power Up Your Team-Building Consistency Challenge* necklace?**

No. You do not need to be registered for or attend Seminar in order to receive your prize. There is no longer a tie with the consistency prizes and events. The *Powered by Pink Power Up Your Team-Building Consistency Challenge* prize will be included in your next product order that follows the end of the challenge and June month end.

**15. Will I receive a 1099 for this *Powered by Pink Power Up Your Team-Building Consistency Challenge* if I earn the prize?**

Yes. As an independent business owner, you are required to report your Mary Kay business activities to the IRS, including prizes and awards received from Mary Kay. Per the IRS, Mary Kay will issue a Form 1099-NEC for Independent Beauty Consultants and Independent Sales Directors who receive commissions, prizes or

awards in excess of \$600 in a calendar year. You will also receive a Form 1099-NEC if your wholesale purchases total \$5,000 or more in a calendar year.

**16. Is there a report that can help me track my qualifications?**

The *Powered by Pink Team-Building* Consistency Challenge Report will track your progress for the *Powered by Pink Power Up Your Team-Building* Consistency Challenge. *Mary Kay InTouch*<sup>®</sup> > Business Tools > *myBusiness*<sup>SM</sup> > Reports > Contests and Promotions > *Powered by Pink Team-Building* Consistency Challenge Report.

**17. Is the monthly cumulative \$600+ wholesale Section 1 order requirement *adjusted* or *unadjusted* cumulative wholesale Section 1 sales volume?**

It is adjusted wholesale Section 1 product orders.

**18. How does the adjusted wholesale Section 1 sales volume affect the requirements for me to earn my monthly jewelry piece?**

**Adjustments made during the month:** Any adjustments you make to your personal cumulative wholesale Section 1 sales volume during the month will count toward your monthly jewelry piece sales volume order requirement.

- If your order still meets the minimum requirement of a cumulative \$600+ wholesale Section 1 order, you can earn a jewelry piece for that month, and that month also will count toward any current consistency challenge.
- If your adjusted wholesale Section 1 sales volume falls below the minimum cumulative \$600+ wholesale Section 1 order requirement, you are not eligible to earn a jewelry piece. If you already have received your jewelry piece before your adjustment was made, you do not need to return the jewelry piece; it is yours to keep. However, you are not eligible to earn credit for any current consistency challenge associated with achieving that month's *Powered by Pink* Challenge since you did not actually meet the minimum cumulative \$600+ wholesale Section 1 order requirement. Note that you are not eligible to earn the consistency challenge jewelry piece either.

**Adjustments made after the month has closed:** Any adjustments you make to a given month, after that month has closed, will be updated and reflected on your *Powered by Pink* report on *myBusiness*<sup>SM</sup> on the *Mary Kay InTouch*<sup>®</sup> website.

- If your adjusted cumulative wholesale Section 1 sales volume falls below the minimum cumulative \$600+ wholesale Section 1 order requirement, you are not eligible to earn credit for any current consistency challenge associated with achieving that month's *Powered by Pink* Challenge since the minimum cumulative \$600+ wholesale Section 1 order requirement was not maintained. You can, however, keep that month's jewelry piece you received.

**19. What is *Powered by Pink Power Up Your Team-Building PLUS*?**

*Powered by Pink Power Up Your Team-Building PLUS* is for Independent Beauty Consultants and Independent Sales Directors who achieve the *Powered by Pink Power Up Your Team-Building* Consistency Challenge plus add an additional three *Great Start-qualified\** new personal team members during the challenge time frame, for a total of six!

**20. What are the qualifications for *Powered by Pink Power Up Your Team-Building PLUS*?**

There are two qualifications to achieve this challenge. Independent Beauty Consultants and Independent Sales Directors need to:

- Earn the *Powered by Pink* Yearlong Program by selling enough product to place a \$600 wholesale Section 1 order every month during the challenge time frame.
- Add six *Great Start-qualified\** new **personal** team members during the challenge time frame.

**21. What is the challenge time frame for *Powered by Pink Power Up Your Team-Building PLUS*?**

The *Powered by Pink Power Up Your Team-Building PLUS* time frame is April through June 2022. The two qualifications must be met by June 30, 2022, to be eligible to earn onstage recognition at Seminar 2022.

**22. What is the prize for *Powered by Pink Power Up Your Team-Building PLUS*?**

Those that achieve *Powered by Pink Power Up Your Team-Building PLUS* will be eligible to earn special onstage recognition at Seminar 2022!

**23. What if I debuted as an Independent Sales Director in May or June 2022? Can I participate in *Powered by Pink Power Up Your Team-Building PLUS*?**

Yes. You can participate in the challenge. The *Great Start-qualified\** new personal team members from April, May and June 2022, will count for this challenge before you became a Sales Director.

**24. Can I achieve both *Powered by Pink Power Up Your Team-Building Consistency Challenge* and *Powered by Pink Power Up Your Team-Building PLUS*?**

Yes. You can achieve both *Powered by Pink Power Up Your Team-Building Consistency Challenge* and *Powered by Pink Power Up Your Team-Building PLUS*.

**25. I cannot attend Seminar 2022, but I achieved *Powered by Pink Power Up Your Team-Building PLUS*. Do I receive another prize?**

No. In order to be recognized for achieving *Powered by Pink Power Up Your Team-Building PLUS*, you must register for and attend Seminar 2022 in person for your onstage recognition. You will still earn your necklace in your next product order for achieving the *Power Up Your Team-Building Consistency Challenge*.

\*A *Great Start*-qualified team member is one who has personal retail sales of \$600 or more in wholesale Section 1 products within the *Great Start* time frame. The wholesale order(s) to support this retail sales amount can be a single order or cumulative orders.

The *Great Start* time frame is the month her/his Agreement is received and accepted by the Company plus the following three calendar months. Agreement is received and accepted by the Company.

All independent sales force members need to be in good standing with the Company in order to be eligible to earn the challenge prize.
